4. NATURAL GAS

Supplier's tariff + 10%

Project approval, deposit, security deposit, gas-meter fee, natural gas distribution loss within the zone, natural gas supply maintenance, repair and administrative expenses and/or other fees should be paid to the Supplier shall be reflected to the user companies.

Assurance Fee: The main amount in the assurance fee is the monthly consumption of the 2 consecutive months in which the monthly withdrawals listed from the companies on the 1st page of the service contract to be made with the companies are at maximum. The Assurance Fee is calculated by multiplying this amount with the sales price specified in Article 3.3 of the Special Terms and Conditions of the natural gas contract and adding all kinds of funds, taxes and KOSBAŞ shares.

Natural Gas Maintenance Billing will be made as explained below:

5. ENVIRONMENTAL LIGHTING

Environmental electricity consumption of user companies are calculated in proportion of the size of the land they use in accordance with below mentioned formula:

a) Service costs will be invoiced at the end of each month.

b) Collection of domestic waste is carried out two days a week and on Tuesdays and Fridays unless otherwise specified.

c) Domestic waste containers that do not have a Kosbaş chip on them will not be taken.

- d)** The use of household waste containers other than domestic waste is strictly prohibited.
- e)** A container that does not meet the Eighty Percent (80%) occupancy requirement will not be processed until the next collection day.
- f)** The maintenance/repair responsibility of the household waste containers delivered to user companies by Kosbaş belongs to the user company. If the maintenance/repair works are carried out by Kosbaş, the relevant company will be invoiced accordingly.
- g)** The number of staff to be invoiced will be determined in accordance with the average number of persons including not only the User companies' permanent staff, but also the staff worked for them during the month through subcontractor companies who do not have a licence.
- h)** The total construction area of the facilities will be determined according to the value shown in the building permits.
- i)** The changes in the number of staff and the total construction areas of the User companies, are taken into consideration within the invoice term of the following month .
- i)** In order for the Users to collect their household waste, KOSBAŞ will provide the requested volume of containers upon payment by the User.
- j)** Container/containers that become unusable will be renewed by KOSBAŞ at cost.
- k)** No service is provided for domestic wastes that are not placed in waste containers.
- l)** An occupancy fee of \$100/per service is charged for waste and other materials left in common areas without permission within the zone. For waste materials removed by KOSBAŞ, the transportation fee is charged separately.
- m)** The number of personnel to be taken as basis for the invoice (including subcontractors) will be sent to KOSBAŞ in writing on the last day of each month. If not notified, the calculation will be taken from the average of 500 or more people. The number of personnel to be notified should be compatible with the number of personnel registered in OSGB.
- n)** The number of persons is sent to the Service Company and KOSBAŞ on the last day of each month. SGK records are taken as basis for numbers. For false notifications, the highest number of workers in the last 12 months will be taken as basis.

7. PENALTIES RELATED TO THE ENVIRONMENT

- a)** Penalty amount of public organizations and institutions will be reflected to User / Users within the same month in case the User/Users who caused this penalty can be determined. In case there are more than one Users for the referred penalty amount, then the amount will be distributed in proportion to the average no. of monthly workers. In case the User who caused this penalty can not be determined, the referred penalty amount will be distributed to all Users in proportion to the average monthly number of workers they employ.

Distribution formula :

H : Penalty amount

n (each) : The average number of monthly workers of the User/Users to be referred

N (each) : Total monthly average number of workers of the User/Users with production purpose (in case User/Users could be determined, then, their total employee number will be considered. In case User/Users could NOT be determined, then the total employee number of all Users with production purpose will be considered)

- b)** In case it is determined that wastewater and/or any kind of other wastes, garbage, rubble, construction wastes are discharged to empty areas or to the sea by means of drainage canals and rain water channels, a penalty given by public organizations and institutions or the amount over \$1.000 will be determined and be charged to the related User/Users.

c) Each User who will benefit from the sewerage system of KOSBAŞ must obtain Channel Connection Permit from KOSBAŞ. Each User who makes an unauthorized connection without channel link permission will be fined \$ 1,000.

d) KOSBAŞ will take wastewater samples from the common discharge point (pumping station) and channel connection points belonging to each user in the periods specified in the Channel Connection Permit and when it deems necessary, and have it analyzed at the cost of the user / users. In case the analysis values do not meet the limit values in the current legislation annex, KOSBAŞ will take samples again from the waste water exit point of each user in order to determine

the source of the problem and have the necessary analyzes done at the cost of the user / users. With this analysis, if the user / users who do not meet the limit values in the regulation can be determined, all costs regarding the cleaning of the pumping station and sending the generated waste to the licensed company will be reflected to the relevant user / users within the same month. If there is more than one user to be recourse, the relevant fee will be shared according to the average monthly number of workers employed by the users. Regulation limit

If the user / users who do not meet the values cannot be determined, then, all the costs regarding the cleaning of the pumping center station and sending the generated waste to the licensed company will be distributed to all users in the same month in proportion to the average monthly number of workers they employ. In addition, the analysis fees that come to the agenda as a result of the audits made by the official institutions will be reflected to the relevant users with + 10% KOSBAŞ service share.

e) Sanction fees to be applied for containers, semi-trailers, trailers, palletized or non-palletized materials, wastes, trashes, construction debris left on KOSBAŞ roads, vehicle loading / unloading areas, open areas and parking areas of Kocaeli Free Zone will be calculated as:

d) If leftover hazardous and non-hazardous wastes are left on the roads, on vehicle loading & unloading areas and on parking zones of Kocaeli Free Zone, Except for penal sanctions, KOSBAŞ will be sent to licensed companies in cases where KOSBAŞ deems necessary and all related costs will be reflected to the user.

e) In cases where it is determined that any waste is discharged to the KOSBAŞ sewerage and storm water line, the provisions in paragraph b are applied to the relevant user (s). The damages that occur in the infrastructure system for this reason will be reflected to the relevant User/Users.

8. MAINTENANCE AND REPAIR OF RAINWATER DUCTS & SEWAGE CANALS'

a) In case KOSBAŞ can not solve malfunctions with its own means and that it solves by outsourcing services, then the invoice amount will be charged from the User/Users within same month if the User/Users causing the malfunction can be determined. If there is more than one user to be recourse, the invoice amount will be shared in proportion to the average monthly number of workers employed by the users. In case User/Users causing the malfunction can not be determined, then, the referred invoice amount will be distributed to all Users in proportion to monthly average number of workers they employ.

The maintenance and repair amount to be shared = (H x n) / N

Where :

- **H** : Amount for external service
- **n (each)** : Average number of monthly workers of the User/Users to be referred for production purpose
- **N (each)** : Total average number of monthly workers of the User / Users with production purpose (in case User/Users could be determined, then, their total employee number will be considered. In case User/Users could NOT be determined, then the total employee number of all Users with production purpose will be considered)

(No fee is taken for that month in case no external service is received for maintenance and repair of the sewage during the month)

b) In case rainwater canals of common areas are blocked, they will be cleaned by KOSBAŞ. The cost of this application will be reflected to users according to the table given in Article 6.

c) The users have no permission to get sewage truck service to open sewage canals without informing KOSBAŞ authorities. If such an action is noticed, then a penalty of \$100 will be applied.

d) The opening of waste water system manhole covers without KOSBAŞ's knowledge is precisely forbidden. If such an action is noticed, then a penalty of \$100 will be applied.

11. PUBLIC HEALTH AND SAFETY UNIT (OSGB) SERVICES

A) Health Unit Services: : 0.30 USD / Person / Day (As Fixed Expense) *

To be provided free of charge by KOSBAŞ; Except for the first intervention, aid and lifeguard needs required in case of injury and sudden illness in work and other accidents; It includes illness, epidemic intervention, injection, dressing, etc., poisoning and various treatments.

- In the calculations, the number of persons is multiplied by the number of days with SSK (Social Insurance Institution).
- Service fees will be invoiced at the end of each month.
- The number of persons is sent to the service company and KOSBAŞ on **the last day of each month**. SGK records are taken as basis for numbers. For false notifications, the highest number of workers in the last 12 months will be taken as basis.
- During the calculation of man-day, special occasions like weekend holidays, official holidays, religious feasts, etc. are included and considered as "worked days" as per provisions of Articles 46 and 47 of the Labor Law.
- In case it is noticed that given number of employee is less than the actual one, for the missing number of employees, a penalty will be applied two times the amount determined by the formula \$ / person / day in the tariff for under-reported number.
- Periodic inspection and IGU-Occupational Safety Specialist fees will be invoiced to companies separately.

13. FEES FOR VEHICLE ENTRANCE STAMP

* For cards issued after September 1 of the current year, a discount of \$ 15 will be applied and a fee of \$ 20 / item / current year is charged.

REMARKS

Parking of the vehicles on the roads and places out of general parking areas within Kocaeli Free Zone is not allowed.	
<u>Personnel service vehicles</u> will exit the Free Zone within 30 minutes after they enter the Free Zone or they will park in the private parking area in the own parcels of the Users. The personnel service vehicles may park in the vehicle park place outside the zone of KOSBAŞ after they exit the zone.	
The sanction fee to be taken from the vehicles (including personnel service vehicles) that park inside the free zone inside the user's own parcels and outside the general parking lots inside the zone:	10 \$/day
Entrance permission of those vehicles that violate the rules and/or do not pay obligatory amount/amounts within specified period, will be suspended until the payments are completely paid and entrance permissions of those vehicles will be cancelled if the violations are repeated. No refund will be made for cancelled vehicle entrance stamps.	
The User Company that signs the application form is responsible for the payment of vehicle entrance stamps and obligatory amounts. However, vehicle owner or its driver may realize the payment in the name of the related User Company. The invoice is then sent to the related company.	
The vehicles that park in Kocaeli Free Zone and the passengers inside them must be insured against all kinds of damages, losses, harms, theft, fire, sabotage, earthquakes and similar events in addition to Traffic Insurance. KOSBAŞ does not have any responsibility in such kind of events.	
In return of a written application to KOSBAŞ, for those vehicles whose license plates have changed within related period and/or for those vehicles that are purchased after sales, provided that old vehicle entrance stamps are returned and the license information is deemed appropriate, new vehicle entrance stamp will be provided free of charge.	
The information regarding private vehicles, service vehicles and subcontractors' vehicles that leave the job or that belong to companies starting to provide service to another user company, should be given to KOSBAŞ in written form for cancellation of vehicle entrance stamps and the stamps should be returned back to KOSBAŞ as a letter attachment. Obligatory amounts (park penalties) that may originate due to uninformed vehicles and unreturned stamps, will be charged from the first user company who demanded vehicle entrance stamp.	
If the speed limit determined within the zone is exceeded and high speed is detected in the zone, the relevant vehicle will be fined 10 \$. The vehicle that was previously penalized cannot be allowed to enter the zone.

(*) **Heavy construction equipments:** All kinds of cranes, trucks, tractors, excavators, loaders, dozers, graders, breakers, trailer tractors, fork-lifts, pile driving equipments, bored piling equipments, channel opening machines, jet grout machines, anchorage driving machines, steel pile driving machine, vibratory driving machines, road and asphalt cylinders and the similar vehicles/machines.

- a) Out of working hours, the tariff is increased by 50% on working days until 22:00, and 100% on Saturday, Sunday and public holidays.
- b) In compulsory situations, for overtime works after 22.00, 200% increased tariff will be applied.

- a) Tariffs are implemented for each half hour and its multiples. If KOSBAŞ vehicles/equipments will not be suitable, then the cost of vehicles/equipments supplied from third parties + 10% will be charged for the service provided.
- b) If a special attachment other than the standard attachment of the forklift is needed, KOSBAŞ has the right to supply this attachment or to request the supply from the user.
- c) Out of working hours, 50 % increased tariff is implemented until 22:00 (10:00 pm) during the week and 100 % increased tariff is implemented during weekends (Saturdays & Sundays) and official holidays.
- d) If overtime after 22:00 (10:00 pm) is needed for obligatory cases, then 200% increased tariff is applied.

- a) It is subject to the permission of KOSBAŞ for the users loading/unloading the vehicle from their own business / workplaces by their own means, and in such cases, 20% of the fee in the table is paid separately for each transaction.
- b) Outside of working hours, the tariff is increased by 50% on Saturdays and 100% on Sundays and public holidays.
- c) In cases where it is not possible to unload the goods brought to the zone from the transport vehicles, 20% of the charges in the loading / unloading price tariff are paid separately for both transactions and the following formula is applied for additional storage for 1-15 days. In the cost of goods account specified in the formula, the CIF exit price of the product from the region is taken as basis.

- d) All the provisions of service tariff are valid for purchases and sales within the Zone. However, if the type of vehicle and no. of runs can not be determined, then tariff of 2,1 \$/ton is applied (if weight is known), but this fee can not be less than 5,4 \$ and more than 53,8 \$. If the weight can not be determined or calculated, then a fee of 5,4 \$ is charged for each transaction form.
- e) The bulk liquid loading/unloading tariff is applied for the Ship (pipe-line).
- f) The above vehicle tariffs cover loading & unloading of goods with pallets and boxes by fork-lifts and which do not require additional manpower. In case manpower is required, then additional service fees are charged for the equipments and teams used during loading and unloading.
- g) Loading /unloading is not carried out at KOSBAŞ warehouses after 22.00 (10:00 pm). If overtime after 22:00 (10:00 pm) is needed for obligatory cases, then 200% increased tariff is applied.

16. PERSONNEL CATERING SERVICE FEE

a) Food service to the users in the region is provided only by KOSBAŞ.

b) Usage amounts of raw beef and chicken meat used in meals according to the type and group of the meal are as follows.

The amount of beef used in meat dishes is as follows.

- 180 - 200 gr (such as kebab, doner)
- 160 - 180 gr (such as paper kebab, forest kebab, kebab with vegetables)
- 40 g of meat used in meat vegetable dishes and legumes (as cubed or minced meat)
(such as green beans with minced meat, baked beans with meat, fried potatoes)
- 120 gr of meat used in meatballs (all kinds of meatballs)
- The amount of chicken used in chicken vegetable dishes is 50 g (such as potatoes with chicken)
- The amount of chicken used in chicken meals is 240 - 250 gr (such as chicken leg cooked in oven)

c) "Service personnel" food service is provided free of charge to the users in the zone in accordance with the table below. Food service with "distributor" (cafe staff) is provided free of charge to the users in the region within the framework of the table below

Users requesting more service personnel are charged an additional \$ 1,000/month per additional service personnel.

d) Service tools and equipments to be provided by KOSBAŞ together with the meal :

e) Those that can be demanded besides 6 dishes of meal :

f) The Users have to inform the no. of meals latest on 17.00 (05.00 PM), previous day. However, user companies may change order number with a written notice within the same day up to 11:00 o'clock for dinner orders of the next day.

g) After the operation of new cafeteria building, the meals below 50 persons will be served in central cafeteria and no serving will be provided to the Users' facilities.

18. FREE ZONE ENTRANCE DOOR SECURITY SERVICE

Service Fee: \$ 35 (Security Camera Service Fee) + Security Staff Service Fee

- Obtaining Zone Entrance Gate Security Service is one of the services that must be received by all regional companies, except for companies operating in the region with AAKB * or DKB ** certificates.
- Zone entrance is monitored by 4 high resolution outdoor IP cameras.
- Firms can provide instant access to cameras with the given system login passwords.
- Firms can request images stored in the system 1 year retrospectively.
- Security personnel of 5 people with the necessary qualifications and certificates work at the entrance gate of the zone in shifts between 08:00 and 00:00.

20. CONFERENCE HALL SERVICE

If the participants are requested to provide catering, the fee to be paid will be invoiced separately from the conference room fee.

21. VEHICLE ACCESS SYSTEM

For the Vehicle Access System installed at the Zone Entrance, the card reader module required in the service vehicles will be procured from KOSBAŞ. It is mandatory for every service vehicle to purchase a card reader module.
